  - Introduction of DKA staff members.
  - Membership 1353 members, regular communication was introduced in our monthly newsletter
  - Strategic plan safe clean and inviting downtown, membership engagement, advocacy and relationships, marketing and promotion, expansion
  - Committee for expansion into Brewery district because we're getting calls for support from DOC
  - Levy increased by 1%
  - Fully staffed teams now (DOC 8 employees and CT 4 employees)
  - Calls to RCMP have decreased by almost 50%, incidents have decreased as well (6.3% of the time the RCMP is called)
  - Provincial and local politicians contacted us to assist URBA in the creation of their On Call team

- MARKETING & EVENTS used a local company to create our website. Increased page-views across the board. Social media has been contracted out and we have a summer student handling some social media posts
- MMOB 400 & 500 blocks are not being closed this year a vote was put to City Council, most businesses in the 2 blocks did not like the street closed
- Night Market started in 2024 10% are DKA members

President's Report

- Spoke about the time as President and the partnership between the City of Kelowna and the DKA for Parks Alive.
- 2023/24 was still a time of recovery for our downtown broadly and our members specifically with social issues, challenges relating to the evolving drug-enforcement policy, to wildfires
- Recognition from the City of Kelowna and MLA Renee Merrifield that our DOC program was a model of excellence that should be replicated in other neighbourhoods
- As a policy-driven "governance" Board, we fine-tuned some Board systems, the on-boarding process to welcome new Directors and two new committees, "Member Engagement" and "Expansion"
- The Board worked hard to identify member's pain points and advocate for solutions
- Acknowledged the DKA staff, sincere appreciation for the many hours of hard work they invest in our downtown.
